



Credit players,

Margaritaville Casino & Restaurant Biloxi is now accepting credit applications. Credit limits will be based on the following guidelines:

1. Previous gaming history
2. Banking information

Minimum credit limits accepted \$1000. Markers will be issued starting at \$500. All markers will be held for 7 days, any other hold lengths must be approved by the credit committee.

Credit accounts must be set up prior to arrival or at the beginning of your trip. Margaritaville Casino & Restaurant Biloxi will not issue or extend credit after guests have experienced a loss during their trip.

Temporary increase available up to 10% of the established credit line at beginning of a trip or prior to a trip as requested for a 3 day period. Credit accounts can be set up prior to arrival by filling out the online credit application. Below are the instructions:

1. Provide all information on the credit application.
2. Sign the credit application.
